### **Photography Group IOTY Entry Judging:**



The "2017 Image of the Year" competition was judge by Philip Ramsden from Sydney. Philip's association with the Camera Club movement is over 50 years in Australia, USA and London. He is a Life Member of the Mosman Camera Club, Sydney. Philip has been surrounded with photography all his working life (Pathology) where he had to use camera equipment, particularly taking photomicrographs on glass plates.

Philip's personal photographic journey has taken him around the world (USA, Canada, Europe and South America) including the legendary "Overland" route across Europe to Asia and finally to Australia in 1971. He continued to develop his photographic skills (and

supplement his income) with wedding photography.

Working microscopic photographic equipment it wasn't long before Leica invited him to work in their Microscopic Division. This led him to teaching for Leica and at Sydney TAFE. Philip says he always carries a camera and takes all sorts of subjects, however street photography

has always been his passion.

So it was behind "closed doors" that Philip began to evaluate the various Print categories selecting four images from each category to briefly comment upon during the evening's Awards segment. The Photography Group's Competition Director (Ruth Brooks) was on hand to provide Philip with any assistance, moving prints and awaiting for his final selection decisions.



With the final decision collated, the doors to the venue were opened and the members began to arrive for the evening's formalities.

Philip had judged the EDI entries over the previous week with the Competition Director being advised of his selections for the commentary session.

#### **Annual Dinner and Awards Presentation:**

The club's Treasurer, Brendon Parker, was this evening's MC and he extended a warm welcome to the 54 members and guests to the 2017 Annual Dinner and Presentation Night. Brendon opened the evening with a general outline of the night's activities. He then welcomed the club's President, Bruce Shaw, to the podium.

On behalf of the Wollongong Camera Club's Management Committee Bruce said it was his pleasure to extend a warm welcome to our members, their guests and our very special guest Judge, Philip Ramsden from Sydney for the Club's 2017 Annual Dinner and Awards Presentation Evening.

This year marks the 73rd year of our club's formation and there have been approximately 60 years of Presentation Dinners of one sort or another commencing with the Monochrome "Kodak" Trophy in 1947.

Before continuing with the evening's programme Bruce said that he wished to draw the members' and guests' attention to several safety items before we sit back to a relaxing and pleasurable evening.

- In the unlikely hood that the room requires evacuation then the pathway was through the Emergency Doors and external stairs and then follow the pathway to the club's main carpark;
- If a nature call is necessary then these are located down the hallway; and
- Should anyone wish to partake of the club's bar services, then it is located outside the room's entrance and just down the hallway.

Bruce then handed the stage back to Brendon for the first part of the club's Awards and the introduction of the judge. Brendon reminded all that to create a small fortune as a photographer one had to commence with a large fortune. He also commented upon image quality saying that often he heard a judge say "... the image quality would be improved with better equipment..." Having embarked down the path of better equipment

Brendon noted that the judges' would continue to remark about his images' quality. One wonders if there is a moral to this.

Brendon introduced the guest judge, Philip Ramsden, outlining the many characteristics that they both shared; loved photography, professional life was behind a microscope and shared similar photographic equipment. After that Brendon noted their "shared" paths diverged especially along the image recognition path.

During the main course a slideshow of the Photography Group's Image of the Year entries for all categories were shown. In all there were 55 EDI's and 94 Prints that had been entered.

John Devenish introduced the Movie Makers' 2017 Award achievements and with the assistance of Ian Simpson operating the laptop and sound system presented the various Movie Makers productions. In all there were three videos and two Audio Visuals (A/V's) shown.






Philip had already judged this category prior to attending the Dinner and Awards Evening. His general comments were "... what a challenge. I can only imagine how good the prints will be."

#### **Photography Group's Encouragement Award**

President, Bruce, was invited by Brendon to announce the winner of this award. He spoke briefly about the Award's history and how it came to be part of the club's Awards saying it commenced in the early 1990's when the then Vice President, Bill Foott, brought 2 proposals to Club's Management.

1. The first was to introduce a Small Print Category to counterattack the dwindling membership and the increase effect of the 1-Hour Photo Service. Thus the Small Prints commenced and still going a quarter of a century later.

2. The second proposal; the introduction of an Encouragement Award based upon the photographer's developing skills in both image taking and competition results. This Award was limited, being awarded at the Management's discretion. In the early days it was a voucher and later a Trophy was obtained for presentation.

Bruce then turned to tonight's recipient briefly speaking on their club membership noting that they first joined the club in 2011 and then had a short break before re-joining in 2014. During this time this member has been active in the Small Prints section. During their later period they have managed to develop their picture taking skills, though with modest results. In 2017 they have manage several Best in Sections, Merits and Credits. They have even topped the Club's Entries in the FCC 2017 Interclub "Colour Prints – Open" out scoring some of the Club's "A" Graders.

Bruce said it was a pleasure to announce the 2017 Photographic Group Encouragement Award recipient; Michael Cherviakov. He then invited our guest judge, Philip Ramsden, to present Michael with this much deserved Award.

#### **Photography Group's Encouragement Award**

The President, Bruce, was called upon to announce the "President's Award" recipient for 2017.

He briefly commented on the institution of this Award noting that a former President, Craig Parker GMAPS, EFIAP, PPSA introduced it in recognition of a member's service to the Club. This year's recipient has invested many years serving the club in one form or another from Management to working in the background. They have served 11 terms as President, 4 terms as Secretary and another couple of terms as a Management Committee Member. He has also served on the club's 1982 APSCON Organising Committee and on the three (3) occasions that the club has been the APS National (1988, 1995 and 2000) Organising Committee.

In recent years he became aware that most of the Club's functions are being carried out by a couple of members, so he campaigned for changes in this for the club's continuance sake, thus newer members have been introduced to the club's operating mechanisms. In 2016 a new Competition Management System came to his attention and after a rigorous investigation, and discussion, noted that this ticked the boxes for the club.

Bruce said it was a great pleasure to announce that the 2017 President's Awardee is Brian Harvey. He also took the time to extend the club's gratitude to Kath Harvey in supporting Brian throughout the many years, since about 1971. Bruce presented their daughter, Susannah, with a small token of the club's appreciation in Kath's absence as she was still recovering from a recent bush walking incident. Thank you, Kath and we wish you a speedy recovery.
